Judge Carter stated the income received is at 92%, Property Taxes are at 102% other taxes at 84% Detention Center is at 90% License and Permits at 86% Fees of Tax Collector at 94% Grants at 73% Office Fees at 68% JP Fines at 68% Fines and Forfeitures at 104% Interest is at 71% Miscellaneous including Refunds is at 86%.

Scott Dyer stated the figures reflected are for 75% of the fiscal year.
