Jill Holmes, Purchasing Agent has revised specifications for the building and recommends an aggressive timeline with a pre-proposal conference on May 6th at the location of the building.

Bethany Aries, Extension Agent-Family & Consumer Sciences stated the layout was drafted by Jamie Ray Walker.

Scott Dyer, Auditor asked if there was an allowance for IT space.

Ms. Aries stated there is no IT space drafted in, but it had been recommended a portion of a work room be allotted or in a back office, but it is expected a contractor can better address that.

Jill Holmes, Purchasing Agent stated the purpose of this agenda item is to award a vendor and an amount to include the access control for the 336th District Court hallway access, surveillance system DVR and extra cameras in the courthouse.

Ms. Holmes stated the South Annex quote is for \$1,525 to cover two cameras and a panic alarm.

Judge Carter stated for clarification the total funds requested are \$10, 953.

ITEM 13. CONSIDERATION AND ACTION TO APPROVE BUDGET AMENDMENT FROM CONTINGENCY #10-509-475 TO PRISONER MEDICAL #10-565-405 – AUDITOR

Scott Dyer, Auditor stated additional prisoner bills have been received plus estimates for the rest of the year for transport, prescriptions, emergency room visits, personnel and hospital costs which are expected to be about \$65,000 to \$67,000; there is \$89,000 left in Contingency; it is requested the Court approve \$6,347 for current bills due plus estimated future spending for a minimum of \$40,000 to \$45,000.

Commissioner Barker moved to approve \$40,000 to be moved from Contingency to Prisoner Medical.

ITEM 14. CONSIDERATION AND ACTION TO APPROVE CHANGES TO FANNIN COUNTY TRAVEL POLICY – AUDITOR

Scott Dyer, Auditor stated the changes are meant to clarify the existing policy of 2008 (which had a slight change in 2009 going from using the Texas Mileage Chart to Mapquest); the current changes are in bold of Expenses Incurred and to the Reimbursement Expenses incurred when traveling from the home to a conference center or from the office to the conference center, whichever is the lesser of the two.

Richard Glaser, Criminal District Attorney stated an employee had charged mileage from his home in Collin County to Texarkana and the submission for reimbursement was rejected; the next trip taken from the employee's home to Dallas was charged from Bonham to Dallas in an attempt to comply with the earlier determination of using the office to the conference based upon the policy, that submission was also rejected. Mr. Glaser recommended the policy be simplified to

state mileage will be from the courthouse to the conference; in many cases shorter trips to Windom and back are not charged for reimbursement at all.


