Judge Carter called the meeting to order at 9:00 a.m.

ITEM 2. ESTABLISH A QUORUM

Judge Carter declared a quorum has been established.

ITEM 3. PUBLIC FORUM

Gail Young, Tax Assessor/Collector thanked Commissioner Magness and Precinct 3 for installing the hands-free towel dispensers and Jill Holmes, Purchasing Agent for researching the best pricing which allowed for purchase of dispensers in all bathrooms in the County buildings; Sonic Boom starts today and ends July 1st.

Tammy Biggar, County Clerk stated Early Voting is still being conducted and can be completed from 7:00 am to 7:00 pm today and tomorrow.

ITEM 5. CONSIDERATION AND ACTION TO APPROVE ANNUAL FINANCIAL REPORT FROM RUTLEDGE CRAIN & CO. FOR FISCAL YEAR 2011-2012 – AUDITOR

Lewis Crain of Rutledge Crain & Company presented the annual report and stated the County's General Fund balance is above the recommended amount; the Road and Bridge Funds for Precincts 1 and 3 and are slightly low and Precincts 2 and 4 are in good shape; pages 37 and 38 show \$1,437,000 above what was budgeted [in the General Fund] due to the County planning to use \$600,000 of reserves but not using those funds and therefore coming out ahead.

Mr. Crain stated consideration should be given to the Liability fund for unfunded pension costs; this item will be reflected on the report in about two years; this particular fund is underfunded and will be recorded as a liability; this does not have an affect on day to day operations but will have an impact on the rate of bonds and issuance of grants; one county opted pre-fund this item in advance, there may or may not be a benefit to doing this.

Mr. Crain stated the county auditor, Scott Dyer has drafted an MDNA (Management Discussion & Analysis) on page 5 of the report which is an overview for management.

Jill Holmes, Purchasing Agent stated the 366th District Court has requested additional access controls for the security door; Advanced Alarm has a system for \$497 which uses a camera, speaker and remote release button; an additional button for the bailiff would be \$50; the South Annex cost for 2 additional cameras would be \$576; a quote was given to upgrade the DVR with an 8 channel systems would be \$1,132.

Ms. Holmes stated due to previous savings on equipment for the South Annex, only \$318 is needed; the total for the District Court and South Annex comes to \$865.00.

Nancy Young, District Clerk requested a panic alarm.
