Jill Holmes, Purchasing Agent stated the stated two local vendors submitted bids for shading: Custom Glass & Mirror for \$2,500 and Tri-County Glass for \$2,300 for the tinted glass; it is recommended the film not be considered due to wear and tear; the darker tint will work well, the lighter is of nearly no value. Commissioner Barker stated the film will bubble after a short time.

Jill Holmes, Purchasing Agent stated the County Clerk had requested new carpeting during Budget Workshop, the Auditor recommended funds were available from the current budget in Courthouse Repair and Maintenance; estimates were provided by Carpet World in Paris, Walker & Son has not responded for a quote request. Ms. Holmes stated Carpet World quoted \$6,427.53 to cover the 5 suites including labor, materials and moving furniture with the exception of the juror chairs in the courtroom; color needs to be chosen, the "Hop-a-Long" color seems to be the most popular and therefore recommended; the carpet is a mid-grade carpet.
