Sheriff Donnie Foster stated signage is also a help to clearly delineate the boundary. Mr. Hutchins stated the right-of-way is a 15' boundary. Commissioner Magness stated a 3rd class road is required to be 12' minimum.

Judge Carter stated to be clear; the road is not a county road.
