CALL TO ORDER

Judge Carter called the meeting to order at 9:03 a.m.

INVOCATION

Commissioner Dean Lackey

ITEM 2. ESTABLISH A QUORUM

Judge Carter stated all commissioners are present.

ITEM 3. PUBLIC FORUM

Richard Glaser, Criminal District Attorney / Board Member of the Multipurpose Complex gave a rebuttal to comments made last week with regard to the Complex operations and explained how the by-laws are structured; when they were drafted and by whom.

Roy Cirkles stated speed limit signs and enforcement are requested at the fairgrounds as evidenced by several incidents that occurred over fair week.

Judge Carter stated citizens are permitted to comment on agenda items, some comments may be offensive to others and the Court may agree or disagree with comments made [but cannot respond during public forum].

David Stapp, Chair Elect for the Chamber of Commerce, stated for two years the Chamber has managed the Complex; no funds have been mismanaged.

ITEM 5. DISCUSSION, CONSIDERATION AND ACTION TO APPROVE RESOLUTION SUPPORTING FANNIN COUNTY MULTIPURPOSE COMPLEX'S SUPPORT FOR USDA GRANT FUNDS - CHAMBER OF COMMERCE

Dale McQueen, Executed Director of the Bonham Chamber of Commerce presented the request for three items to be funded 55% by the USDA and 45% by the Complex; a resolution is requested.

Richard Glaser, Criminal District Attorney / Board Member of the Multipurpose Complex stated he is in favor of the resolution.

John Burnett, President of the Multipurpose Complex Board of Directors submitted an informational sheet to the Court reflecting a timeline of expenditures and grants. Mr. Burnett stated the President-Elect is Ray Clark, the Secretary is Joe Moss; other members of the Board include Joe Ward, Gary Edwards, Russell Green, Gary Whitlock, Judy Keene, Chad Burnett and Stephen Murden.

Mr. Burnett discussed Board by-laws structure, transparency, monthly reporting, annual reporting, meeting postings, notifications via email and asked the Court for specific instances of suspected impropriety.

Commissioner Barker stated he had been to two meetings where business was conducted without a quorum. Mr. Burnett disagreed.

Mr. Burnett stated no funding is asked for by any taxing unit, the County does not contribute funding but has provided services; materials are billed to the Complex and paid for; the Complex operates off the interest of an endowment fund from a grant that was provided, additionally BEDCO provided a specific-use grant of \$250,000 and that money was used for the specified purposes.

Judge Carter stated the Court needs to review the documentation regarding the relationship the County has with the Complex to decide what involvement if any, the Court should have.

Commissioner Barker stated the old by-laws required an annual accounting; an accounting should be brought to the Court. Mr. Burnett stated the by-laws were changed years ago, the information is readily available.

Joe Moss stated as secretary of the Board it has been his duty to send out copies of the Minutes to the Board after each meeting, the purpose of having a commissioner on the Board is to keep the Court informed; once the Chamber contracted to manage the Complex the Chamber held the meetings and report back to the Board; if the Court needs something more the Board will comply.

Mary Payne stated when she was the secretary for the Board she was required to post the agenda and meeting notice at the courthouse.

Tommy Eskue stated support and appreciation for Board and Dale McQueen in particular.

Tom Turner, Owner-Fannin County Leader stated he had presented to the Court two years ago a report with financial information and long range planning; over \$1,000,000 was given as a gift, \$300,000 was set aside, the interest is used for operation shortfalls. Mr. Turner stated the USDA requires County approval before they will release the grant; Randy Bowen manages the fund.

Joe Ward stated unity is called for; the Board supports the Court and hopes the Court will support the Board.

Richard Davies of Honey Grove stated appreciation for the County conducting open meetings and being open to discussions.

 - (a) DISCUSSION, CONSIDERATION AND ACTION TO APPROVE EXECUTION OF FACILITY OPERATION AND MANAGEMENT AGREEMENTS FOR THE OPERATION AND MANAGEMENT OF THE FANNIN COUNTY DETENTION FACILITY (432 BEDS) AND FANNIN COUNTY JAIL (96 BEDS) COUNTY JUDGE

Herb Bristow, Haley & Olson, P.C. presented the contract stating the draft presented is in the final form for the facilities; there are two separate agreements; one is for the 96 bed facility [the other for the 432 bed facility]; the contracts are for a 5 year term; the per diem rate is fixed for county inmates at \$36.25 and U.S. Marshall inmates at \$38.25; the vendor will reimburse all installation costs for the Odyssey contract, which is attached and incorporated; the vendor will provide a staff member at the courthouse for transportation and security on site during regular business hours.

Mr. Bristow stated there is a \$10,000 annual reimbursement for law enforcement training and an additional \$10,000 annual scholarship to be disbursed at the discretion of the Court; transportation costs will be set at the Federal rate and \$15.00 per hour for the transportation personnel.

Mr. Bristow stated his recommendation the Court authorize the county judge and sheriff to sign the contracts for the 96 and 432 bed facilities.
