## ITEM 8. DISCUSSION, CONSIDERATION AND ACTION TO REAFFIRM THAT THE PRESENT FANNIN COUNTY POLICY ON HOLIDAYS APPLIES TO ALL EMPLOYEES OF FANNIN COUNTY – AUDITOR/TREASURER

Judge Carter asked for clarification from Scott Dyer, Auditor.

Mr. Dyer stated it is unclear whether it is intended by the Court for employees to be compensated for 12 hours of Holiday pay, other departments have some employees working 10 hour days and currently use 2 hours of comp time or vacation to get a full day's pay.

Commissioner Lackey stated the Sheriff's deputies do not have an option of what hours they work on a shift.

Commissioner Barker stated if the Sheriff's department maintains holiday pay for the full 12 hours, the department must clarify which employee is eligible.

Sheriff Foster stated dispatch and patrol both work the 12 hour days.

Commissioner Barker moved to maintain the current policy of 8 hours Holiday pay for the courthouse and Road and Bridge; the Sheriff's Department to include a 12 hour Holiday pay with a list provided in advance of who qualifies, in particular dispatch and patrol.

ITEM 11. CONSIDERATION AND ACTION TO APPROVE SERVICE CONTRACT FOR THE COURTHOUSE HVAC ANNUAL MAINTENANCE AGREEMENT, WATER TREATMENT AGREEMENT, UPGRADES TO THE WATER TREATMENT EQUIPMENT, AND APPROVE BUDGET AMENDMENT TO COVER COSTS FROM CONTINGENCY FUND AND AUTHORIZE COUNTY JUDGE TO SIGN SERVICE CONTRACT ON BEHALF OF FANNIN COUNTY – COUNTY JUDGE

Jill Holmes, Purchasing Agent stated the old contract was for \$4,500 and a new contract would be \$14,635; another bid was sought, ACIS in McKinney offered \$13,527.24; further research showed the water treatment to be the catalyst in the price increase, specifically the chemical used as a scale and corrosion inhibitor; an upgrade for the control center was recommended.

Ms. Holmes recommended ACIS for maintenance only at \$7,428.94, and use JenTek for water treatment costing \$3,900 for an annual cost of \$11,328.94, then follow up with upgrading the water treatment equipment for \$3,436; total costs for all improvements being \$14,764.94 including 12 months of maintenance and water treatment; there is \$841.25 left in the line item used for the current contract; \$9,886.39 would be needed for the rest of this fiscal year which includes eight months of maintenance, seven months of water treatment and upgrade of the water treatment equipment.

Scott Dyer, Auditor stated it is recommended Contingency not be considered but an amendment be made to cover maintenance and water treatment line Item 445 and transfer the costs for that, \$7,227.64 to be used for maintenance and take the upgrade out of normal Repair & Maintenance.
