## Fannin County Commissioners Court June 9, 2020

#### **SUBJECT: Changes to County Road Numbering**

On June 9, 2020, the Commissioners Court of Fannin County, Texas met in a regular session with the following members present and participating, to wit:

During such session, the Court discussed and considered the changes being made to the County road system related to the construction of Bois d'Arc Lake and the need for renumbering various segments of roadway.

Thereupon, a motion was made and seconded and carried with a unanimous vote of the Court to adopt the following Order.

#### ORDER NO. 2020-06-09a

**WHEREAS**, Section 251.016 of the Texas Transportation Code states the Fannin County Commissioners Court may exercise general control over all roads, highways, and bridges in Fannin County; and

WHEREAS, Section 251.051 of the Texas Transportation Code allows the Fannin County Commissioners Court to order public roads to be closed, abandoned, altered, or vacated; and

WHEREAS, Section 251.052 of the Texas Transportation Code allows the residents of a Fannin County precinct to apply for a change in an existing road by presenting to the Fannin County Commissioners a petition requesting such a change to an existing road; and

**WHEREAS**, the North Texas Municipal Water District ("NTMWD") is developing a water supply reservoir on Bois d'Arc Creek in the Red River Basin in Fannin County, Texas, which was named "Bois d'Arc Lake"; and,

**WHEREAS**, Bois d'Arc Lake will be impounded approximately 15 miles northeast of Bonham, Fannin County Texas; and,

WHEREAS, NTMWD and Fannin County entered into that certain Agreement between North Texas Municipal Water District and Fannin County, Texas Concerning Water Supply and Development of the Lower Bois d'Arc Creek Reservoir Project on or about June 22, 2017 ("Agreement"), relating to NTMWD's and Fannin County's cooperation in the development of Bois d'Arc Lake; and,

**WHEREAS**, Section 3.f.ii (Impacts of County Roads) of the Agreement specifies twenty-seven (27) County Road crossings as being impacted by Bois d'Arc Lake in the 2011 Transportation Plan; and,

**WHEREAS**, the Agreement by Fannin County and NTMWD regarding these County road crossings is to convert one (1) County road crossing into a private driveway, close five (5) County road crossings, retain thirteen (13) County road crossings as-is, and to reconstruct eight (8) road crossings; and,

WHEREAS, CR 2917, CR 2950, and CR 2955 were severed due to road closures and removal of existing bridges and were renumbered in the Round 1 renumbering effort; and,

WHEREAS, Round 1 of the County road renumberings were discussed, considered, and approved on May 5, 2020; and,

WHEREAS, CR 2915 and CR 2655 were severed due to the construction of "new" FM 897; and,

**WHEREAS**, the existing section of FM 897 in Lannius will be downgraded from a State highway to a County road; and,

**WHEREAS**, the south section of FM 1396 from CR 2745 to the boundary for Bois d'Arc Lake will be downgraded from a State highway to a County road; and,

**WHEREAS**, the north section of FM 1396 from FM 2029 to the boundary for Bois d'Arc Lake will be downgraded from a State highway to a County road; and,

WHEREAS, various other existing County roads require extension or renumbering to be consistent with connecting roadways impacted by construction or closure; and,

**WHEREAS**, upon renumbering the County roads, NTMWD will continue to coordinate with Texoma Council of Governments to finalize the renumbering effort, assist with new addressing, and assist, as needed, with necessary notifications.

# NOW THEREFORE, BE IT HEREBY ORDERED BY THE FANNIN COUNTY COMMISSIONERS COURT THAT:

The following roads, or portions thereof, are to be renamed or renumbered:

- 1. The existing "old" FM 897 in Lannius from US 82 to "new" FM 897 shall be renamed to Lannius Rd.
- 2. The existing east-west section of CR 2915 from "new" FM 897 to "old" FM 897 in Lannius shall be renumbered to CR 2918.
- 3. The existing south section of FM 1396 from CR 2745 to the boundary for Bois d'Arc Lake (33.673154, -95.975476) shall be renamed to Old 1396 South.
- 4. The existing north section of FM 1396 from FM 2029 to the boundary for Bois d'Arc Lake (33.696707, -96.003324) shall be renamed to Old 1396 North.

- 5. The existing east-west section of CR 2655 from the "new" FM 897 to CR 2615 shall be renumbered to CR 2654.
- 6. The existing north-south section of CR 2730 from the intersection of the existing southmost east-west section of CR 2730 to the intersection of the existing northmost east-west section of CR 2730 was renumbered to CR 2725 on May 5, 2020. With this action, it shall revert to CR 2730.
