No action on behalf of Fannin County will be taken at this meeting. Notice is given that a quorum of the Commissioners Court may be present as Directors of the Public Facility Corporation and notice is given solely for the purpose of providing disclosure thereof.

OPEN MEETING: Fannin County Detention Center in Fannin County; Discussion and action on the following matters concerning the Fannin County Detention Facility, including: Detention Services Agreement with U.S. Marshals Service; operation and management of the Facility; and other matters related to the Fannin County Detention Facility, including but not limited to the following:

- 3. Review and approve minutes from previous meetings;
- 4.
