**ORDER DESIGNATING COUNTY ROAD 2520 AS A RESTRICTED TRAFFIC ZONE  
AND ADOPTING TRAFFIC CONTROL DEVICES ON COUNTY ROAD 2520  
RESTRICTING “NO THRU TRUCK TRAFFIC” IN FANNIN COUNTY, TEXAS**

On the 13 day of May, 2025, after due notice as required by law, the Commissioners Court of Fannin County, Texas, meeting in regular session, took up for consideration and action the following matter: Order to establish County Road 2520 as a restricted traffic zone and designate County Road 2520 as a “No Thru Truck Traffic” road.

WHEREAS, The Texas Transportation Code, Chapter 251, Section 251.151, authorizes the commissioners court of a county to regulate traffic on a county road or on real property owned by the county that is under the jurisdiction of the commissioners court; and

WHEREAS, The Texas Transportation Code, Chapter 251, Section 251.155, authorizes the commissioners court of a county to adopt restricted traffic zones and establish traffic control devices on County roads; and

WHEREAS, The Fannin County Commissioners Court has identified the need to establish County Road 2520 as a restricted traffic zone, and establish traffic control devices to promote the safety and welfare of the citizens; and

WHEREAS, the Fannin County Commissioners Court is exercising this authority to designate County Road 2520 as a “No Thru Truck Traffic” road; and

WHEREAS, The Texas Transportation Code, Chapter 251, Section 251.161, establishes a violation of an order issued by the Commissioners Court under this subchapter as a misdemeanor.

**NOW, THEREFORE, BE IT ORDERED BY THE COMMISSIONERS COURT OF FANNIN COUNTY, TEXAS:**

SECTION 1. **THAT** the matters and facts recited hereof are hereby found and determined to be true and correct;

SECTION 2. **THAT** truck traffic on County Road 2520 in Fannin County, Texas is causing or may cause a safety hazard to the citizens of Fannin County and is causing or may cause substantial damage to the road;


SECTION 3. **THAT** County Road 2520 is now designated as restricted traffic zone restricting “No Thru Truck Traffic.” Signs shall be posted on County Road 2520 in compliance with the Manual and specifications of the Texas Department of Transportation;


SECTION 4. EFFECTIVE DATE.

This Order shall be in full force and effect from and after its date of approval.

**IT IS FURTHER ORDERED, ADJUDGED AND DECREED** that this restriction may be enforced by any and all law enforcement officers of the State of Texas in conformity with State law as a misdemeanor, pursuant to Texas Transportation Code Chapter 251 § 251.161. A person convicted of a violating the restriction imposed by this Order may be punished by a fine not to exceed two-hundred dollars (\$200.00), pursuant to Texas Transportation Code § 251.161. The actor who violates the restriction may be prosecuted under Texas Transportation Code § 251.161, or under other State law if the act constitutes an offense under any other law.


