OF \$60,000 AND APPROVE THE LETTER OF INTENT AND COURT ORDER TO BE SIGNED BY COMMISSIONERS AND COUNTY JUDGE AND BE ATTESTED BY THE COUNTY CLERK – COMMISSIONER PCT. 3 AND PURCHASING AGENT

Commissioner Magness stated he and outgoing Commissioner Mr. Dewayne Strickland had visited Collin County to look at the tractors and mowers offered for sale; both are in good working condition, are clean and the mowers are in good condition as well; by of a cost comparison Bane Industries offers a new tractor and boom mower for \$93,000 or boom mower only for existing tractor for \$46,000.

Jill Holmes, Purchasing Agent stated equipment purchased from Collin County in the past has been of good quality and regularly maintained.

Commissioner Magness stated Precinct 3 has one tractor-mower in the shop, once it is repaired it can be sold and used to subsidize the cost of the two being purchased.

Commissioner Magness moved to approver the purchase of the two tractors and mowers.

Scott Dyer, Auditor stated \$30,000 would need to be moved from Precinct 3 Contingency Fund to pay for the equipment.
