Judge Carter stated the leakage in the courthouse must be addressed.

Jill Holmes, Purchasing Agent stated she would seek quotes for both the window replacements and roof drainage.

ITEM 8. CONSIDERATION AND ACTION TO APPROVE INVOICE REGARDING AGRILIFE OFFICE FURNITURE – COUNTY JUDGE

Judge Carter stated furniture has been chosen for the new building. Commissioner Barker stated the purchase of furniture would be premature without knowing remodeling costs. Jill Holmes, Purchasing Agent stated proposals for the remodeling are due tomorrow. Commissioner Magness stated furniture is required and moved to approve and move \$2,914 into a new Office Equipment line item.

Scott Dyer, Auditor stated \$89,300 was budgeted and this will reduce the amount available to \$86,386.

ITEM 9. DISCUSSION, CONSIDERATION AND ACTION TO RENEW PARTICIPATION IN TEXAS COUNTY AND DISTRICT RETIREMENT SYSTEM PLAN BENEFITS FOR 2013 – AUDITOR

Scott Dyer, Auditor stated the increase based upon present salaries would be \$18,500; with the expectation of the annual increase in salaries of 3%, the total increase would be \$26,000.

Judge Blake stated as anticipated \$75,000 will be needed to meet the demands of court reporter costs and costs incurred for other professional services; \$45,000 is requested at this time.

Scott Dyer, Auditor stated there are shortfalls of \$400 for the Court Reporter line item and \$11,500 for Professional Services; there are anticipated costs of \$25,000-\$30,000; an estimate of \$40,000 more is expected to meet current demand.

Commissioner Barker stated his concern over the strain on the Contingency Fund for repairs. Mr. Dyer stated there is \$28,000 currently available in Courthouse Repair and Maintenance.

Commissioner Barker moved to approve \$32,500 into Professional Services and \$2,500 into Court Reporter Expense.
