Commissioner Whitlock stated Precinct 1 is in good shape; Commissioners Barker and Magness stated their respective Precincts were also in good condition.

ITEM 7. CONSIDERATION AND ACTION TO APPROVE FANNIN COUNTY AUDITOR'S MONTHLY REPORTS FOR MAY 2013 – AUDITOR

Scott Dyer, Auditor stated the previous 8 months of activity reflect the County income up \$494,000 compared to this time last year in part due to two one time distributions from the Appraisal District and one from Health Insurance for a total of \$258,000; fees collected by the Tax Assessor/Collector have been collected already, which is \$175,000; the County has expenditures of \$693,000 above last year, \$229,000 of the increases are one time expenses for the purchase of AgriLife Building and jail expense are up \$240,000; all departments are over compared to this time last year with the exception of the County Clerk's office which is slightly down because imaging expenses are down.

Mr. Dyer stated specifically the AgriLife Building costs are \$229,000, the District Judge is up \$63,000, District Attorney is up \$32,000, jail expenses are up due to housing and medical by \$240,000, \$34,000 has been paid to Juvenile Probation which is also ahead of this time last year.

Judge Carter stated the AgriLife expense was anticipated and is a one time expense. Mr. Dyer stated the purchase is one-time and the electric and water will be recurring expenses.
