ITEM 8. Jill Holmes, Purchasing Agent stated the terms and conditions are the same as the contract for the AgriLife building; some infrastructure is needed in the amount of \$1,676.00.

Dustin Morrow, Network Administrator stated Cableone also has a \$50 installation fee; projects slated for next year will need the increased internet speeds.

Scott Dyer, Auditor stated the funding to come from the Courthouse Computer Equipment fund 510; the cable will be tested and then is expected to be less than the current rate through Verizon.

Scott Dyer, Auditor stated the amendment is presented for consideration.

Richard Glaser, Criminal District Attorney/County Attorney presented the request.

Commissioner Barker stated according to the Minutes the challenging expert was expected to cost between \$2,000-\$4,000; the next estimate given was for \$10,000 to \$15,000 and the bill presented is for \$25,000.

Mr. Glaser stated an insanity defense was a possibility in the Tauntan murder trial but evidence pointed to that not being the case; preparation had to be made in the event that defense was brought up; due to the shortness of time there were no local psychiatrists available and an expert was found in California; the psychiatrist interviewed the defendant for 17 hours, plus the costs for travel.

Mr. Dyer stated \$30,000 is what is needed from items pending and witness fees, recommended from the Contingency Fund.

Mr. Bristow stated some specifications will include the joint operation of facilities, a marketing plan and the usage of Odyssey, the continuity of the contract with the U.S. Marshalls and the Department of Labor HR compliance be adhered to; a 5 year contract with (2) 5 year renewal options; insuring agreements, indemnification and hold harmless agreements; vendor provides transportation to and from the courts, medical and other facilities; noticing is requested for 4 consecutive weeks as per statute.
