Judge Moore called the meeting to order at 8:30 am.

1. Establish Quorum;

All members were present, quorum established.

2. Public Forum;

Mr. Newt Cunningham made comments regarding the presentation for Belle Vie he attended. He stated they are looking to do something different with the peninsula area of the property ending on FM 1396. He feels there would be variances requested in the future regarding their ideas.

3. Approve meeting minutes from 10/06/2022 Public Hearing and Regular Meeting;

Lisa Loiselle pointed out two errors in the minutes: 1) incorrect date in the heading – should state 10/06/2022 rather than 09/01/2022 and 2) incorrect meeting name - should be Regular Meeting instead of Public Hearing.

 - **KD** Pointed out that this would be a 2-acre lot and a 3-acre lot.
 - **RM** Confirmed.
 - **GW** Stated if the owners wish to subdivide any further in the future it may require a plat, but currently the request does comply with the Regulations.

KD – Feels a lot of people will be wanting to divide their lots in the future and we cannot say yes to one and not do the same for others. There needs to be consistency.

GW – Does not see that there is any opposition to this division or change in zoning. If in the future there is opposition to other lots being divided, that could be a reason for denial of the application.

Mr. Welch moved to recommend to the Commissioners Court to approve the change in zoning application. Seconded by Mr. Titsworth. Motion passes 5-0.
